Након увида у достављени захтев и достављену документацију Министарство заштите животне средине је на основу одредби Закона о управљању отпадом („Службени гласник РС“, бр. 36/09, 88/10, 14/16 и 95/18 - др. закон и 35/2023) утврдило да исти није потпун.

У том смислу и у складу са чланом 59. став 1. Закона о општем управном поступку („Службени гласник РС“, бр. 18/16, 95/18 - аутентично тумачење, 2/23-одлука УС), чланом 72. и 72а Закона о управљању отпадом, чл. 4. став 3. тачка 3). Уредбе о

листама отпада за прекогранично кретање, садржини и изгледу докумената који прате прекогранично кретање отпада са упутствима за његово попуњавање („Службени гласник РС”, бр. 34/2022) и члан 4. Правилника о садржини документације која се подноси уз захтев за издавање дозволе за увоз, извоз и транзит отпада („Службени гласник РС”, бр. 60/09, 101/10, 48/17, 80/17, 98/17, 38/18 и 6/21) обавештавамо да у року од 30 дана од дана пријема овог дописа извршите допуну документације у вези са Обавештењем бр. ВГ 003924 за издавање предметне Потврде.

Уколико у остављеном року не допуните Ваш захтев траженом документацијом, министарство ће захтев одбацити као непотпун, у складу са чланом 72. и 72а Закона о управљању отпадом и чл. 59. став 2. и члана 92. Закона о општем управном поступку.

The submitted Notification BG 003924 with accompanying documentation from the Competent Authority of the country of export (*No. VO-153-00(2)/08.11.2024. on 08.11.2024.*) will be used for the purpose of issuing the Consent and Certificate of transboundary movements of waste from the list of non-hazardous waste for which no permit is issued and which is subject to control procedure, on territory of Republic of Serbia.

After insight into the submitted request and submitted documentation, the Ministry of Environmental Protection, based on the provisions of the Law on Waste Management („Official Gazette of RS“ No. 36/09, 88/10, 14/16, 95/18-other law and 35/2023) determined that the same was not complete.

To that end, and in accordance with Article 59 of the paragraph 1. Law on General Administrative Procedure 18/16, 95/2018 - authentic interpretation and 2/23-decision of CC) Article 72 and 72a of Law on Waste Management, Art. 4. Par. 3 item 3) of the Decree on waste lists for transboundary movement, content and appearance of documents accompanying transboundary movement of waste with instructions for its completion ("Official Gazette of RS", No. 34/2022) and Rulebook of the contents of documents to be submitted with the application for a permit to import, export and transit of waste („OG of RS“, No. 60/09, 101/10, 48/17, 80/17, 98/17, 38/18 and 6/21) inform that within **30 days**

from the date of receipt of this letter, please supplement the documentation in connection with Notification No. BG 003924 for the issuance of the subject Certificate.

If you do not supplement your request with the requested documentation within the deadline, the ministry will reject the request as incomplete, in accordance with Article 72. and 72a Law on Waste Management and Art. 59. paragraph 2 and Art. 92. Law on general administrative procedure.

In accordance with the law, Exporter shall submit on ENG language the following:

1. Statement on the planned cross-borders *in the original*
2. Permit for the transport of non-hazardous waste issued to the Carrier "Eurorail Logistics" d.o.o. Belgrade by the competent authority: Serbia *in copy*

Note: the permit no. 19-00-00714/2019-06 from 19.12.2019. is not in the validity period

3. Insurance policy or bank guarantee for the amount needed to cover the cost of processing non-hazardous waste without risk to the environment *in original*
4. Insurance policy of intended carrier or bank guarantee on the amount needed to cover the cost of environmental rehabilitation as a consequence of damage to the packaging during transportation, the beneficiary of which is ministry *in original*
